Coty Inc. announced the completion of its acquisition of **P&G Specialty Beauty Business**. Coty is now the third-largest beauty company in the world, with approximately **\$9 billion** in revenue.

Pfizer Inc. announced the successful completion of its acquisition of **Medivation, Inc.**

ConAgra announced the acquisition of the packaged foods businesses of **Frontera Foods, Inc.** and **Red Fork LLC**.

3M announced it has completed the sale of its temporary protective films business, formerly known as **Polymask**, to **Pregis LLC**.

Tessera will acquire **DTS** for \$42.50 per share in an all-cash transaction that is valued up to roughly **\$850 million**.

Constellation Brands acquired **High West Distillery** for approximately **\$160M**.

Teva sold **Actavis'** UK and Ireland assets and operations to **Intas Pharmaceuticals' Accord Healthcare Limited** for **\$766 million** to clear hurdles to their **\$35 billion** acquisition of **Actavis**.

Molson Coors Brewing Company completed their acquisition of **SABMiller's 58% stake in the MillerCoors JV**.

LVMH - Moët Hennessy Louis Vuitton announced the purchase of an 80% stake in German firm **Rimowa** for **\$713.3 million**.

Dole Food Company announced the acquisition of the **TucFrut** farms and packing facilities in the Molina and Linares areas of Chile.

ICU Medical agreed to purchase **Pfizer's** global infusion therapy business for **\$1 billion** in cash and stock.

AdvancePierre Foods completed the acquisition of **Allied Specialty Foods** for **\$60M** in cash.

Chemtura announced it has entered into a definitive agreement to be acquired by **LANXESS AG** in a transaction valued at approximately **\$2.5 billion**.

US Foods announced it has agreed to acquire **Jeraci Foods**, an Italian specialty distributor based in Elmsford, New York.

Eli Lilly's Elanco will acquire **Boehringer Ingelheim's** US rabies vaccine business for **\$885 million**.

Utz Quality Foods, the U.S.'s largest privately held snack food company, announced the completion of their acquisition of **Golden Enterprises, Inc.**

Grey Mountain has acquired **Kronos Foods**, a leading Mediterranean food manufacturer and distributor, primarily serving the foodservice market.
