**Church & Dwight** has agreed to acquire **Water Pik**, maker of oral hygiene products and shower heads, for **~\$1B**.

**Multi-Color Corp.** is set to buy the Labels division of **Constantia Flexibles** for **\$1.3B**, combining the companies' HPC and F&B businesses.

**Diageo** will acquire super-premium tequila brand, **Casamigos** in a transaction potentially valued at **\$1B**.

**Dow Chemical** agreed to sell part of its **Dow AgroSciences** corn seed business in Brazil to China's **CITIC Agri Fund** for **\$1.1B**.

**Hain Celestial** announced the purchase of **The Better Bean Company** for an undisclosed amount.

**Home Depot** will acquire **Compact Power Equipment** for **\$265M**.

**Estée Lauder** announces that it invested an undisclosed amount in **Deciem**.

**Campbell Soup** has agreed to purchase organic broth/soup maker **Pacific Foods** for **\$700M**.

**Unilever** plans to auction off its margarine and spreads business this fall, according to its CFO. Sources estimate the business could net Unilever about **\$7.5 billion**.

Sources indicate **Costco** is considering a **\$15B** bid to challenge **Amazon's** proposed deal to acquire **Whole Foods** for **\$13.7B**.

**Johnson & Johnson** has completed its acquisition of **Actelion** for around **\$30B** in cash.

**Post Holdings** completed the previously announced acquisition of **Weetabix Limited**, effective July 3.

**Liberty Interactive** is buying the remaining shares of **HSN** in a **\$2.6B** deal to "... enhance **QVC's** position as the leading global video eCommerce retailer," says Liberty CEO **Greg Maffei**.

**Walgreens** and **Rite Aid** struck a new deal whereby Walgreens will acquire 2,186 Rite Aid stores & related assets for **\$5.175B**.

Snack bar maker **Kind LLC**, is reportedly seeking to sell a minority stake in its business it hopes will value its products at more than **\$3 billion**.

French dairy company **Danone** is selling **Stonyfield**, one of its U.S. dairy subsidiaries, to **Lactalis** for **\$875M**.

**Staples** has confirmed a definitive agreement to be acquired by **Sycamore Partners** for **~\$6.9B**.

Boating supplies retailer **West Marine** has agreed to be acquired by **Monomoy Capital** for **\$338M**.
